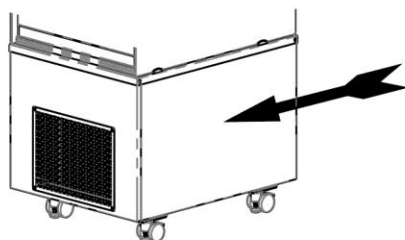
### General Installation Considerations

- 1) Area in which display is to be sited must have a minimum room floor area no less than 17 sq m (PC6HT), 26 sq m (PC9HT), 28 sq m (PC12HT) or 29 sq m (PC15&18HT).
- 2) Install over a sealed floor or ventilated floor void.
- 3) Do not site the display within 2m of ceiling mounted air conditioning grilles.
- 4) Do not site the display beneath a high level of direct sunlight.
- 5) Display will operate in a 24 hour environment.
- 6) Access to maintain condensing unit should be made via removable fascia panels or doors to customer and operator side of counter.

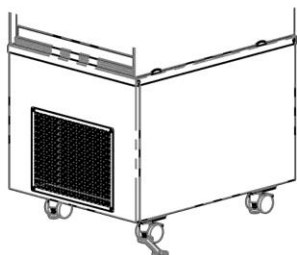
#### A) ROLL UNIT INTO POSITION

UNIT SUPPLIED WITH CASTORS



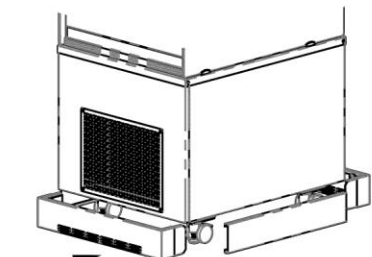
#### B) ADJUST UNIT HEIGHT

#### C) FIT OPTIONAL KICK PLINTH

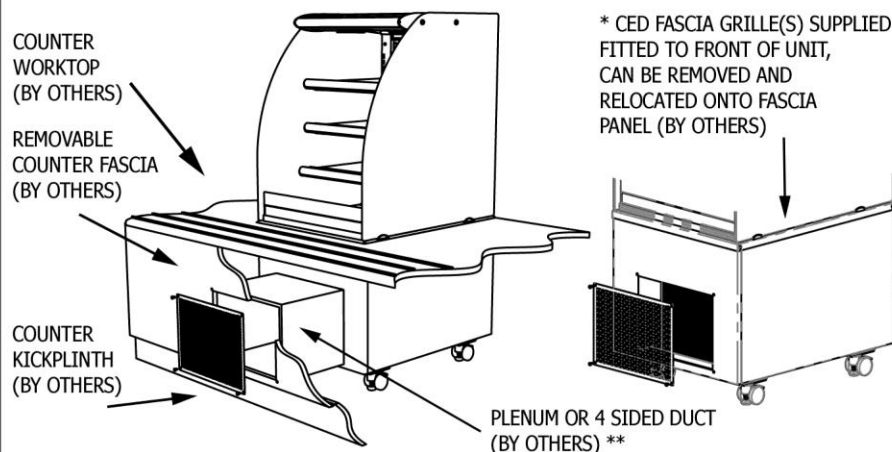
FRONT & REAR LOCATES WITH MAGNETS



NOTE: OPTIONAL KICKPLINTH IS SUITABLE FOR LOWEST ADJUSTED UNIT HEIGHT

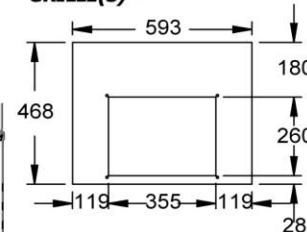
### FREE-STANDING OR COUNTER LOCATED : PC6HT ONLY (FASCIA PANEL BY OTHERS)

#### OPTION1) FASCIA PANEL WITH CUT-OUT FOR CED FASCIA GRILLE(S)

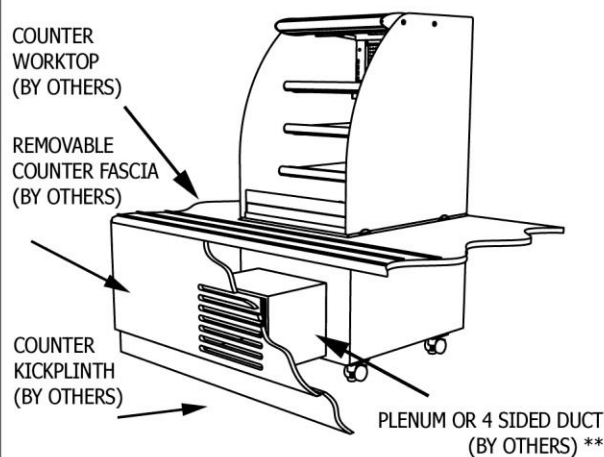


\*\* A PLENUM OR 4 SIDED TUNNEL (MADE FROM MDF, PLYWOOD OR NILFLAM TYPE MATERIAL) MUST BE FITTED BETWEEN THE REAR FACE OF THE CUSTOMER SIDE FASCIA PANEL AND THE FRONT FACE OF THE PATISSERIE, AROUND THE AIR INTAKE CUT-OUT, TO STOP THE RE-CIRCULATION OF HOT AIR FROM THE COMPRESSOR. SILICON SEAL AROUND EDGES TO ENSURE THERE ARE NO AIR GAPS.

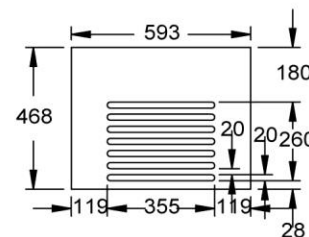

#### OPTION 2) FASCIA PANEL WITH ROUTED SLOTS

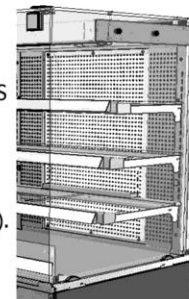


#### SUGGESTED REMOVABLE FASCIA PANEL ROUTING (BY OTHERS)



### FITTING SHELVES

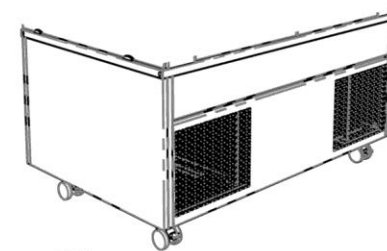
LOCATE SHELF SUPPORT BRACKETS INTO REAR SLOTS AT HEIGHT & ANGLE TO SUIT PRODUCTS (NOTE: SHORTEST BRACKETS AT TOP AND LONGEST BRACKETS AT BTM). REST GLASS SHELVES ONTO RUBBER BUMPERS ON SHELF SUPPORTS. (NOTE HALF-LENGTH SHELVES ARE LOCATED ON BOTTOM TO ALLOW FOR TALLER BOTTLES ON DECK)



### FREE-STANDING OR COUNTER LOCATED : 900/ 1200/ 1500/ 1800 UNITS \*
